Course Fee & Payment

The course fee must be **paid in full within 2 days of the reservation date but before the course starts** by card, bank transfer or invoice. The course book and the fee for an international language exam are not included in the course fee.

Refund

Once you have paid for the course, you can cancel your registration by a written request under these conditions:

- **before the course starts:** you will receive a full refund of the amount you paid minus an administration fee of 30 EUR
- **before the third lesson of the course:** you will receive a full refund of the amount you paid minus an administration fee of 60 EUR and minus the price of the lessons taught
- **after the third lesson of the course:** your cancellation request has to be supported by a doctor's note proving that you are unfit to attend the rest of the course. You will receive a full refund of the amount you paid minus an administration fee of 60 EUR and minus the price of the lessons taught. **No refunds are given after the first half of any course.**

Please note that refunds can only be paid by domestic bank transfer.

Alterations of the Course Programme

British Council reserves the right to cancel the course before its start and refund the full course fee paid to its students.
